Processing In Colorado

State is requiring appointments for drops and dealer resale - Processing 3 at a time

Counter Assistance:

Denver County (Tremont location only) requests have to conform to their policy of the work being within 2 weeks of temp expiration. Dealer titles are dropped

Jefferson County

Douglas County

Colorado is difficult for over-the counter titles and customer processing for dealerships. It appears that most of the back-log is reasonably caught up. It appears that mail-in or drop off is now the norm in most counties.

Make sure you have tracking receipts on all deals.

Make copies of Lien stamped title documents to protect your dealership.

Completing the DR2395 Application for Title

This form directs the clerk to look for documents to properly issue a title for cash - financed or leased deals

- The vehicle information must match the title; bill of sale,DR0024 and DR0026
- Must be submitted with all dealership transactions
- The application for title directs the clerk on how to process your title documents for proper title issuance -
- Boxes checked and completed direct the clerk to the proper DMV screens for processing
- All handwriting must be legible
- Check All boxes most counties do not accept white out on this form
